March is definitely the month to showcase Jewish genealogy in Sarasota. We welcome E. Randol Schoenberg to Sarasota. Mr. Schoenberg is a Los Angeles based lawyer and genealogist specializing in legal cases related to the recovery artworks looted or stolen by the Nazi regime during the Holocaust. He successfully sued the Austrian government for the return of five paintings by Gustav Klimt, including the iconic portrait of Adele Bloch-Bauer, to its rightful owner, Maria Altmann. This famous case, which reached the United States Supreme Court, was depicted in the highly successful film, Woman in Gold, in which Schoenberg's character was portrayed by Ryan Reynolds alongside leading lady Helen Mirren. There is a sneak preview of his new film, the genealogical documentary Fioretta, tracing his family back 500 years to the founding of the Venetian Ghetto. Fioretta will be shown on Saturday, March 25, 2023 at 7:00 p.m. at the Burns Court Cinema. The Jewish Genealogical Society of Southwest Florida has arranged for Schoenberg to present "The Recovery of the Klimt Paintings from Austria" on Friday, March 24 at 10:00 a.m. at Temple Emanu-El (151 McIntosh Road, Sarasota).

I am excited to share with you a genealogy article (with several connections to Jewish roots and Israel) appearing in the March/April issue of Sarasota Magazine. The Jewish Genealogical Society of Southwest Florida "Discovering One's Hidden Jewish Roots" November program was highlighted in the article. Tracing My Jewish Roots: What happens when two sisters marry two brothers and cousins marry cousins

When I was a little girl, my mother tried to explain how everyone in our family was related to me, but I was too young to comprehend what she told me. In 1983 at age 33, I was ready to begin seriously tracing my family. When I first embarked on tracing my family, I had no idea that I would learn genealogy terms in addition to adding names, dates, and places to my family tree.

When tracing Jewish roots, it is not uncommon for a relative to marry a relative. It is also common among Jews for two sisters in one family to marry two brothers in another family. The custom of marrying within the limits of a local community is called endogamy. Jews were often geographically isolated from other people, thus endogamy is prevalent among Jews. Pedigree collapse will happen when two genetically-related people have children together (like first-cousin or second-cousin marriages). This causes the same person/people to appear in your tree multiple times as ancestors. My family tree has lots of endogamy and some pedigree collapse.

My great grandparents, Zlata Klopman (nee Szwarcbort) and Joel Szyia Klopman were first cousins, once removed. Zlata is the great granddaughter of Szmul Klopman and Maryem Szrajer. Joel is the grandson of Szmul Klopman and Maryem Szrajer. Because of this, Szmul Klopman and Maryem Szrajer are my ggg grandparents and my gggg grandparents. This is an example of endogamy, but it is also an example of pedigree collapse. (Note: My Klopman family changed the spelling to Klapman after coming to the United States.)

I have many places on my family tree where endogamy appears. My favorite endogamy examples on my family tree involve my cousin Ruth. Ruth Klapman was born 30 May 1909 in Raciaz Poland. She is my father's first cousin. My father's parents are Morris Klapman and Lena Klapman (nee Matis). Ruth's parents are Sam Klapman and Sarah Klapman (nee Matis). This is a case of two sisters (Lena and Sarah) marrying two brothers (Morris and Sam). Sam and Morris have another brother named Beryl. Beryl Klapman had a son named Frank Klapman. My cousin Ruth married her first cousin Frank. Ruth did not even have to change her last name after she married Frank.

In December 1991, my cousin Linda from Chicago visited my parents and me in Sarasota. I asked Linda if she could help me make a Klapman family tree. She suggested we call Ruth. At that time, Ruth was 82 years old. We called Ruth and she told us the names of all of the Klapman brothers and sisters (Morris, Chaya Machla, Chaskel, Miriam, Rosa, Beryl, Chawa, Sam, Wolf, Sura), their spouses, and interesting tidbits about the family. I still have the piece of paper with all of the notes that I gathered from Ruth that day over the phone.

Ruth was a character. She used to throw my dad (who was 12 years younger than Ruth) up in the air when he was a baby and say Nunny, Nunny and a ha cha cha. That is how my father Aaron got his nickname of Nunny. At age 90, there was an article with her photo in a popular magazine among gamblers called *Card Player*. In the article it said, "She's like everyone's grandmother. She is in the poker room so much that she is something of an unofficial hostess...In her career as a social gambler, she has won four automobiles and more poker jackpots than she can count." She was asked by the person interviewing her for her age. She answered, "Can you keep a secret?" The person interviewing her said that he could. She replied, "So can I!"

Tracing Jewish roots can be confusing and time consuming. But with cousins like Ruth, incidents of endogamy, and a surprising incidence of pedigree collapse, it is no wonder that I love tracing my family.


